He had to remove the tele mechanism in the steering wheel, the steering wheel itself, the directional signal switch, which required removing some AC duct work, the ignition switch, and finally the key buzzer switch. Chapter Meeting Location


The location for Chapter meetings is at St. Peter's Episcopal Church located at 6013 Lawton Avenue, Oakland, CA 94618.


