1963 Hood Grill Restoration

The hood grills are a big part of the 1963 Corvette's distinctiveness, and they really have to look good as part of a complete restoration. Sure, there are reproductions available, but with some effort and \$30.00 in materials you can restore your original grills. If you do choose to restore rather than replace, you have a couple of decisions to make. First, if the bright metal sections of your grills are not too scratched up, then you may want to consider saving the original anodized finish. If this is the case you can simply remove the old paint with lacquer thinner and jump to the painting section of the is article.

If the grills are scratched beyond your satisfaction level, then you can choose to send your grills to a plating & polishing shop and have them restored, or you can do that work yourself by following the steps below. Either way you will need to paint the black areas once the metal restoration is complete. If you are going to have your grills restored and polished professionally, you can jump to the section on painting below.

Removing the Anodizing

Sanding off the anodizing is difficult and will take off quite a bit of material. My grills had some pretty deep scratches so sanding out the scratches pretty much removed all the anodizing. In retrospect, I think first removing the anodizing chemically would have been easier. There are several videos on the internet illustrating how to use EZ-Off oven cleaner to remove the anodizing, or better yet, a plating shop can remove it before you begin. If you decide on the oven cleaner method, make sure you have plenty of ventilation because the sodium hydroxide (caustic soda) in oven cleaner produces flammable hydrogen gas when in contact with aluminum. So, if you smoke, you may want to hold off on that activity while performing this task. You don't want the Hindenburg incident recreated in your garage! Also note that some newer oven cleaners don't contain sodium hydroxide, so you will need to find one that does.

Removing the Scratches

Once you remove the anodizing you need to sand out any scratches on the raised portion of the grills. For ease and uniformity, you are going to sand across the entire surface of the grill, but the paper will primarily contact the raised portions. A good starting paper for deep scratches is 220, if the scratches are light then start with 400. Don't just sand the scratched areas, sand the entire raised surface so that you take off a uniform amount of material and don't create low spots or distort the ridges. Use a soft foam sanding block that will conform slightly around the shape of the ridges, but also keep the paper primarily in contact with the raised portion of the grills. Only sand as much as is needed to remove the scratches. Next, work your way down by hand sanding using 400, 600, 800, 1000, 1500, 2000,

3000-grit papers. You can sand wet or dry, but I find wet sanding reduces the workload and extends the life of the paper. I know this seems like a lot of work, but remember you are only really sanding the ridges so each successive grit only takes a few minutes. Each time you use a finer paper you should sand out all scratches left by the previous paper. The 3000-grit paper will produce a surface free of visible sanding marks, but it won't be shinny.



Polishing

Now that all the scratches are removed you will need to decide if you are going to have the grills anodized or simply polish them. Either way, you will need to polish the raised areas of the grills to obtain the bright metal look. I have found that polishing is best completed using a 3" foam pad, spun in a battery powered drill, with a quality aluminum polishing compound. If you have done a good job sanding, the polishing will take just a few minutes. Once completed, the raised areas should appear bright and clear. At this point you can send your grills to a plating shop to have them clear anodized, or accept the polished surface and move to the painting stage.



Painting

I'm not really sure how the factory painted the black inside the hood grills. I'm sure there are those in NCRS who do know, but it's obvious to me that there were no masking lines or paint edges. Fortunately, the shape of

the grills makes it possible to apply paint to the entire top surface and then wipe it off of the raised areas while leaving it neatly in the depressions. I used a professional grade spray paint from SEM called "Trim Black". This paint has the correct level of sheen and applies very well to bare metal.

Apply a very light layer of paint to the entire top surface of the grill and let it dry for 15 minutes, or until dry to the touch.



Next, take a piece of smooth fabric, like the smooth side of a cut up sweat shirt, and wrap it <u>tightly</u> around a stiff sanding block. Apply lacquer thinner to center section of the fabric, damp but not dripping, and wipe lightly over the grill to remove the paint from the ridges only.



This will take some practice and several passes, and the wiping block must be held very flat. Lead with the rolled edge of fabric, not the lose edge. Move the wiping block across the grill crosswise, not lengthwise, because a crosswise movement has the ridges closer together to better support the block and keep the material from contacting the depressions. You will need to change the material often so count on sacrificing one old sweatshirt.

Once all the ridges are clean of paint, apply a second coat of paint and repeat the process. You can add several <u>light coats</u>, wiping off the ridges between each coat until the desired results are achieved.



If you mess up, no problem, either apply another light coat or just wipe everything off with lacquer thinner and start over. I think I started over on one grill a couple times, whereas the other grill went perfectly the first try. I'm not really sure why, but it may have had something to do drinking coffee while waiting for the paint to dry! Remember, we do this for fun so don't get discouraged, just shake it off and give it another go.



This process takes some patients but with a little practice the results will be quite impressive. Assuming you did not anodize the grills, then after the paint has fully cured (at least a week) you can apply a wax or poly sealer so that aluminum stays untarnished.



The Power of Vinegar By Gary Beaupre

Anyone going to the hardware store these days knows that Grade 8 fasteners (e.g., bolts with 6 radial lines on the head) have an iridescent, yellow/gold appearance. That yellow/gold color is not typical of Grade 8 bolts and nuts manufactured in the 50s or 60s. Back then, Grade 8 bolts, nuts, washers, were either unplated (often dark from heat treatment), or black phosphate, or sometimes silver zinc or cad. Back then, one had to look at the head of the bolt and count the number of radial lines to determine if the bolt was Grade 2, 5, or 8. Unfortunately, several of the Corvette reproduction parts companies provide certain bolts and nuts for C2s that have the incorrect, yellow/gold color. I was faced with this issue with the hardware kit I purchased from Long Island Corvette that is used to secure one end of the steering damper (shock absorber) on my '66.



Years ago, I had de-plated original nuts and bolts using muriatic acid to prep them for replating. Muriatic acid is readily available at stores such as Home Depot or Lowes. Muriatic acid is just another name for hydrochloric acid, and it can vary between 15% and 30% concentration depending on the manufacturer. What I really dislike about muriatic acid is that it is dangerous in terms of the potential to burn your skin, make holes in your clothes, damage your lungs, etc. Plus, it's not easy to dispose of waste acid.

Fortunately, I had recalled reading on the Technical Discussion Board that it's possible to de-plate fasteners using simple, acidic solutions found in your kitchen, such as lemon juice and vinegar. Frankly, I was skeptical that this would work with such weak acids. But what I liked about the idea of using those kitchen solutions is that they are much safer than Muriatic acid. I read that vinegar is stronger than lemon juice, so I decided to try it on my steering shock bolts. I put one of my two bolts in vinegar for 7 hours and much to my pleasure when I took them out of the vinegar I found that the yellow/gold was completely gone. The two images show the de-plated bolt on he left and the original yellow/gold version on the right. Unlike with the use of muriatic acid, which would have stripped off all of the plating down to bare steel, the vinegar appears to have only removed the yellow/gold material and the bolt looked like it had a typical silver zinc plating. I don't know if the vinegar would have completely removed the zinc plating if left soaking for more hours or perhaps days. My goal was just to get rid of the yellow/gold, so I was pleased with the 7-hour result.



Unfortunately, as many of you know, the headmark (letter U) on the reproduction bolt is not period-correct. But unless I can find bolts with the correct headmark, I will use the reproduction bolts. I doubt that most chassis judges would be able to get far enough under the car to see the headmark on these bolts. Getting rid of the obvious yellow/gold color was my only goal since that coloration can easily be seen without getting so close to the bolt to read the headmark. Three cheers for the power of vinegar.

Chapter Meeting Location


The location for Chapter meetings is at St. Peter's Episcopal Church located at 6013 Lawton Avenue, Oakland, CA 94618.


