The reason for selecting this section was because I thought of Operations to be straightforward and not subjective. I was extremely fortunate working with great team members that took me under their wing and before long I was confident enough to download and share my knowledge with the owners. What I found so important too was that sharing personal knowledge is very helpful as well as appreciated by the owners. I know many of you know what I am referring to having done that very thing. Thank you to those that helped and still help me to learn.

The next journey is to take the 1969 through the system. Mike is such a great partner and supporter helping me make this possible. Maybe by 2023 in Indiana. Stay tuned.

June 15, 2021 NCC Meeting Minutes

Chapter Top-Flight Award (CTFA): Jeff Blakeslee

Jeff had no report to give. Sharyl asked if the Chapter had to have two meets a year and the answer is no. Then she asked about the possibility of having a one-day Fall meet and the answer was yes. So instead of 3-point meet, it would be a 2-point meet. This would require no overnight stay.

NCRS President and Region IX Director: Mike Ingham

Mike reported that registrations for the Convention are less than in past Conventions. For those that want to walk-in, the late fee will be waived. To date there are almost 300 registrations for about 500 people and about 95 cars to be judged and displayed.

In Arizona, Dave Brigham presented Dana Richard with his Master Hat. NCC members receiving Performance Verification Ribbons were Gary Bennett and Pete Bergmann. Top-Flight Ribbons were presented to Jeff Blakeslee and Bill Cash for their `63, and Michael Day for his `64.

In Iowa, Dana Richard received a Sportsman Ribbon, and a Top-Flight Ribbon was presented to Tony Stein for his `65. I might have missed others and I apologize. (I am out of practice writing names down and depended on my memory, lesson learned not to do that again). Congratulations to all NCC members!

New Business:

Sharyl thanked those Chapters who participated in the Chapter Challenge Convention Sponsorship and the individual sponsorships that have been received. She thanked everyone for their generosity on behalf of the NCRS National Convention Team. The names will be published in the Convention program.

At the last meeting Sharyl had asked us to come to the meeting with ideas for a Fall Meet location. She mentioned that there is an owner with a `55 who is anxious to have his car judged. Sharyl proposed a one day Mini-Meet and perhaps judging only one or two cars. Glorie McNay suggested Charley Lillard and will contact him to see if he is willing to let us meet at his garage in Woodland.

Next month's meeting will be Tuesday, July 6, both in-person at the Church and remote via Zoom. Sandy has been extremely instrumental in making sure we have the correct equipment to set up a hybrid meeting, meaning in-person at the Church and then those who will plan on joining us via Zoom remotely. Sharyl mentioned that it is great to have choices but she feels it is important to get back to in-person meetings when possible. If nothing else, it should be a fun evening, perhaps a comedy of errors but isn't that the way we learn?

Show and Tell:

There were no show and tell items, but a few reported updates.

Wayne Yurtin said that Chris Moore now has his '63 Z06 in California, after being restored on the East Coast. He took his daughter for her first ride in the car. We, the Chapter, hope to see it soon!

Jeff Blakeslee discussed having his and Bill Cash's '63 judged at the Arizona Regional. They were disappointed by some of the judging. They learned a lot and are now working on making corrections in preparation for the Convention in Palm Springs.

Ken Albers reported that they got the fire rebuild permit and construction will start soon. His new shop will 40' by 50' but will house fewer cars this time.

Mark your calendars, the first NCC hybrid Zoom and in-person meeting is at the Church on July 6. Please let Sharyl know if you plan to attend in person.

The meeting adjourned at 8:00 pm.

His whole demeanor changed, he smiled again, he worked hard at therapy and shocked everybody with his improvement. He drives his CORVETTE regularly and smiles often.

Recently a member of my family survived COVID-19 and faced a long slow recovery. Thankful to be alive, he struggled to breathe and faced enormous daily challenges. One day we talked about putting a portable oxygen tank in one of his CORVETTES and running the oxygen hose and canula from the trunk to the driver. He has improved markedly and has

recently participated in a few car events and smiles all the time.

Whether these recoveries are coincidental or because CORVETTES have miraculous healing powers I cannot attest, but to be safe I suggest when your down, feeling less than great or just need a boost, get in your CORVETTE and smile. It brings you joy, comradeship with wonderful people and a reason to smile.

25 Years: An Editorial

It occurred to me that my 25th anniversary as a member of NCRS was last year, 2020. I guess I wasn't paying enough attention. Since Covid brought everything to a halt, I decided to skip that year completely and install 2021 as my new 25th. Our members lost so much in `20 and I am sorry for their losses.

I started thinking about what I have learned in a quarter century of membership and came to some interesting conclusions. First, Corvettes were never my passion. The first Corvette I even remember was in 1975-1976 when a C2 Coupe pulled into the BP Gas station I was working at during high school. I had to ask the owner where the gas cap was even located. Hey, I was only 16 and to my knowledge Chevy's at the time had their caps behind the license plates. No one in my local community of North Philadelphia had a Corvette when I was growing up. It is so odd to me when I hear so many members tell stories of how they loved Corvettes back in the 50's and 60's and that they were popular. In our neighborhood, blue collar Philadelphia, they did not appear to even exist. In college, (Temple U) we street raced (Chevelle for me) on Front Street near the old Oscar Mayer Hot Dog factory (until the police turned on the hydrants) and we had to move over to JFK Stadium's parking lot. The building is still there. Those were great days. But, I never remember any Corvettes ever

taking part. My passion for cars was muscle -Stripes, Billboards, Shaker hoods, Cowl Induction and Ram Air. Still is today. (Apology in advance) Corvettes put me to sleep. They were/are so boring (feel the same about European Sports cars too). A fair question would be how in the world would I become a quarter century member of a club that celebrates Corvettes? I'll bore you with my story...back in 1993 I was on my way to look at a `70 Mustang. Probably a Mach 1. I was early so I had time. I passed a dealership in Fremont that sold Corvettes. I stopped in to look and I saw a coupe that reminded me (I guess) of the one from 1975 (it was white). I knew nothing about originality. I could care less (more on that later) as long as it was well built, reliable and clean. The price was reasonable. My son Alex and I took it to a car show in Half Moon Bay called "Dream Machines" (or something to that effect). We walked the show and when we came back to our car, there were three (maybe 4) "gentlemen" who were conversing about the car. These "gentlemen" proceeded to tell me in their own manner of politeness what was wrong about my car. For every compliment, there was a correction. And a sales pitch to join their group -the National Corvette Restoration Society. To be truthful, I did not even know if I wanted to keep the car very long. (I have a well-earned reputation for losing interest in cars). I looked them up, went to a meet in Pasatiempo, CA (they made me join just to attend- not a great start) and was put to work as a judge (8 cars, interiors as I remember with the late Patrick Collins). Took the whole *&%* day. This was enjoyable? Not really. But (saving grace) the people I met were for the most part (not the LA attendees) very friendly. I decided to go to a meeting before deciding if I would ever go back. You can probably guess the reason why I turned apprehension into 25 years. The people. Nicest bunch of folks. Still are today. I am a member of a hobby car club because of the people, not the Corvette.

You do form opinions over 25 years. Let me share some personal insights that may be a bit prickly for some to read. I enjoy judging the cars because of the people who own them and the judges and tabs who work so hard. I don't really care (and am generally not impressed) that any particular Corvette is equipped with a powerful engine, or rare, or was a race car. I don't care if it is a tribute or original. You will never hear me use the word counterfeit to describe any Corvette presented for judging. IMHO counterfeit is a legal term to be applied

by law enforcement. Personally, if you want to change the trim (and the tag) - go ahead. If you want to make your engine more powerfulhave fun! I am a hobby judge. Owners present their cars for a qualified opinion against a recognized Chevrolet production standard. Do not be angry if your square peg restoration doesn't fit Chevrolet's round hole design. I realize the valuation that the owner may be seeking is inconsistent with the opinion of an NCRS judge. I for one do not appraise value when I judge. I will never tell you what I think your car is worth and IMHO no implication should ever be offered. If an owner wants to market his car, the valuation is between the seller and buyer, not me. People sell tribute cars every day of the week, privately, through dealers and at auction. It makes no difference to me how the owner represents his offer to sell. I am not an involved party. All of these cars are unique by being affected by their owner(s). Some very unique people that I have met along this journey are why NCRS has been successful and why I stay. Caution- The good comes with the not so good too. In 25 years, I have seen so many attempts to make the owner feel welcome, most notably at chapter events. I applaud that effort. Positive outcomes. I used to attend Regionals and Nationals regularly, but I have pretty much stopped. My business is a convenient excuse. The truth is that I don't like political outcomes. I don't like being told that the Bow Tie vote I made isn't the "desirable" outcome, "so change it". I don't like when senior judges pre-judge a car and gossip and criticize an owner, their car, their restoration or their history. That truly sucks. I don't want to talk about an owner's car behind their back. I am not here for that. Makes me want to get right on a plane to home. A positive outcome is what we work towards, right? There is no better experience than two judges who are working together to help the owner achieve their goal. I repeat that. The best part of judging is not finding fault but assisting the owner to learn and improve- to make progress if that is their mission. To educate them (or not) without being mean, petty or pejorative. Judges train to do this. Unfortunately, in my years of experience, I've witnessed some pretty horrible judging floor behavior at both ends. You may be surprised, but most often at the senior levels of judging and with experienced owners. It is a real shame. I cannot say how often this happens anymore- I'm not as connected as I used to be. I really only started paying attention halfway through my journey.

Another experience that I want to offer surrounds the obvious financial quandary that owners and operators consider. I have no problem with members seeking financial gain from the value of their asset and the protection of their investment. Over the years I watched many members criticized for their business associations or their agendas. I actually think it's a good thing that members join value and hobby together. We grow that way. These are valuable assets. Let's be honest that owners and operators use NCRS's opinion to protect the investment, protect future owners, bring stability to our hobby and turn a profit. Over the years I have listened to reasons why owners and operators who function under a business agenda are ridiculed, even rejected. I cannot for the life of me understand why the service that NCRS provides, that owners pay good money for the privilege to participate, is any more than an implied service rendered to our membership. (To clarify, I am not talking about NCRS trademarks, policy, etc...) Owners often bring their cars to NCRS to increase or justify their value. Again, as a judge, I won't combine valuation with the judging outcomes. As a member, I would have to be unconscious to not recognize the affect that profit has to the valuation agenda. It is always present. Why ignore this? I don't get the logic. Besides the great folks I've met on my journey, I would be remiss if I did not mention the places. Two come to mind over the past 25 years, Gettysburg (with my Dad touring the battlefields) and Mardi Gras with my wife in New Orleans. (Note- I erased the seedy hotel in Gonzales LA and the Lamar Dixon Expo Center from my memory to protect the Mardi Gras portion!). Think about the best places that you ever visited with NCRS and no doubt those trips were unforgettable because of the people you traveled with. Road Tours, plane and bus rides, and meals with my friends. Great memories.

You might have noticed that my best memories have nothing to do with the cars. How funny but it strengthens my conclusion. NCRS for me has always been about the people; friendly, supportive, educational, competitive, and challenging. The cars are pretty cool (and they did finally get smart and started adding some stripes recently). Now if only they could figure out how to bolt a ram air shaker through the rear glass?

I have also had the privilege of being a Chapter Chairperson, and National Convention Chairperson too. Great experiences both and offered me a perspective and friendships that many members do not have access to. I must offer my appreciation for these opportunities. Getting involved in your chapter is the single best way to meet new people, across the country. There is something to be said about sharing the success that our members have when they finish a project. That type of pride is one of the most enjoyable parts of my journey. I always remember that it is the people that made this possible. The cars were just a catalyst. Well. This memo is a whole lot longer than I intended so this is probably the best place to stop.

Here's looking forward to another 25 years.

First photo is of two upper A-arms for 63-82. No pitting, only light surface rust. One A-arm has the original pivot shaft and bushings (not useable). The other has the original, riveted ball joint (not usable). The A-arms can be restored to like new condition with bead blasting or sanding and a new paint job or used as cores in an exchange.



The second photo is of a 64-77 lower A-arm, that will also service 78-82. It has the original, pivot shaft, the original (not useable) bushings and the original (not useable) riveted ball joint.

There is no pitting on the A-arm, just light surface rust. A-arm can be restored to like new condition with bead blasting or sanding and a new paint job or used as a core in an exchange.


