# Challenges Installing Side-Window Glass in a C2 Coupe

This is one of those third time is the charm stories. The original driver's-side door tinted glass on my '66 has a large chip at the top, as though someone had used a screwdriver to try to pry down the window. My car has a July 1966 build date, and my original driver's door side glass has a LA date code, for March of 1966. I was fortunate to be able to find and purchase a nice, used piece of driver's side tinted main glass with a YJ date code, for October of 1965. That's 9 months earlier than my July build date, which is acceptable for judging. The used glass I purchased came mounted in its original sash. The glass seemed to have more or less equal overhang at both ends of the sash, which seemed ideal to me. After I placed the used widow glass and sash inside the door and set the two sash studs into the fore and aft holes in the sliding window regulator channel, I found that the center of the aft sash stud was not centered in the 1" diameter access hole in the inner door surface. The stud center was even with the very rear periphery of the hole. Basically, the stud center line was 1/2'' too far to the rear. Because the stud was so far off center, it was impossible to use a socket to tighten the nut onto the stud. I tried to screw on the nut by finger pressure, but I couldn't get the nut to start on the stud, as though the threads were damaged. After struggling with fingers and needle nose pliers, I decided I had to remove the window/sash and check the threads on that rear sash stud. After removing the window unit, I tried to screw on the nut, and I could not get it started. I then got my 1/4-20 thread restorer die and I found it verv difficult to get the die started on the rear stud, which confirmed the threads were damaged. I used the restorer die to clean up the threads and confirmed that the nut would easily thread onto the stud. I then reinstalled the window/sash in the door and again got the sash studs set into the front and rear holes of the window regulator channel. I tightened the two nuts, using a socket on the front nut, which was not as extremely off center in its access hole. I tightened the back nut using fingers to start and then needle nose pliers, which I grabbed and turned with channel lock pliers.

When I rolled the window up and down it was immediately obvious that the back end of the sash was scraping against the rear fuzzy channel. I knew this would soon destroy the fuzzy material, so there was no option except to remove the window and sash a second time and reposition the sash slightly further forward on the glass. Here are some photos showing the position of the glass in the sash at the rear and the front before I repositioned it.



The left-hand vertical line in each pair of lines is the original location, and the right-hand vertical line is where I wanted to relocate the ends of the sash. The shift I wanted was between 3/8" and 1/2".

Getting the glass out of the original sash was a challenge that took me about two hours. I first sprayed the area liberally with WD 40 where the glass is embedded in glass setting tape within the sash channel, and then I took small, wooden mini popsicle sticks and gently pounded them between the bottom edge of the glass and the bottom of the sash channel. After my stack of popsicle sticks was 5 thick, the glass started to be pushed out of that end of the sash. Earlier I had pounded in one popsicle stick into the other end of the sash, so that when that back end of the sash pivoted up toward the glass as the front end of the sash pivoting away from the glass, the sharpened edge of the sash would hit the wood and not the bottom edge of the glass.

I then used CR Lawrence (CRL) Tuff-Pak Cork and Rubber Glass Setting Tape to reset the window glass into the sash. Although I had previously read on the TDB that the correct glass setting tape for C2 side window glass is 1/32" thick, I had previously learned from resetting another C2 side window that 1/32" (2/64'') tape is definitely too thin. I wound up using 3/64" setting tape (CRL catalog # 770). As an aside, it's possible that 1/16'' tape (CRL catalog # 720) would have worked, but I didn't want to wait two weeks for that thicker tape to be shipped just to try that experiment. The previous side glass I reset six months ago seems very securely held by the 3/64" setting tape. One note about the CR Laurence glass setting tape. There are no user instructions that come with it, nor is there a FAQ page or User Guide on the company website. Nor could I find a YouTube video about using the CRL glass setting tape. The potential for confusion about using the tape stems from the fact that the two sides of the tape are very different. One side has a peel-off film and the surface under that film is slightly sticky. The other side of the tape looks cloth-like and is not sticky. The next photo shows the two sides of the tape.



I called CR Laurence and asked for technical support, but after calling their headquarters in Los Angeles, and regional offices in Oakland and in Chicago, I accepted the fact that they do not have any legitimate technical support people or engineers to talk to. One receptionist who answered the phone at one office offered to do their own Google search for user tips, and I eventually convinced another receptionist to consult with their supervisor. After being on hold for several minutes, the first person told me the non-sticky, cloth side of the tape goes against the glass (based off that receptionist viewing a YouTube video for a product from a different company!) and the other person who talked with their supervisor told me that definitely the sticky side goes against the glass. Faced with that inconsistent advice, I searched the TDB archives for the 4<sup>th</sup>

or 5<sup>th</sup> time in the past 24 hours and I eventually found a posting by Jim Durham, who said: "The black shiny side [of the setting tape] goes against the glass." The black shiny side is the sticky side. That agrees with what the CR Laurence supervisor said, so at that point I felt somewhat reassured. I unrolled about 24" of the 3/64" thick tape, peeled off the removable film and set the bottom edge of the glass along the center of the tape, and then pushed the glass/tape into the sash channel. I did not have to use a rubber mallet like some have described in order to seat the glass and tape into the sash. And that's why it's possible that the setting tape that is 1/64" thicker (1/16'' total) might be a better choice. But that almost certainly would have required the use of a rubber mallet to get the taped glass into the sash. And as I said, the previous piece of side glass I set six months ago seems very secure with the 3/64" tape. I then sprayed the tape and sash channel with an abundant amount of WD 40 and left it for 48 hours to air dry in the sun. After 12 hours, I trimmed the tape ends and the excess tape along the inner and outer surface to be even with the sash. After those initial 12 hours it was clear that the tape was still saturated with WD 40, and the tape had become very sticky. The next two photos show the new position of the glass in the sash.



I then installed the glass and sash in the door for the third time. The first of the next two photos shows the rear access hole in the inner door surface, with the nut tightened onto the sash stud. The second of the next two photos shows the forward access hole.





For both rear and forward holes the sash studs were well centered, and it was very easy to place and tighten the nuts with a 1/4" drive socket wrench. After securing the nuts and installing the lower rear metal window run and snapping the last bubble clip on the fuzzy channel into place, I tested the window operation. It went up and down as smooth as glass (pun intended).

So, the moral of the story is, yes, the placement of the glass in the sash is more important than I originally thought for acceptable window operation. I do wonder how that sash and glass ever worked in the donor car they came from. What I always tell people when I describe doing some restoration project on my car is that I want to do it right and I only want to do it once. That slogan failed me this time. But the third time was the charm. I have to say, after three installations of the driver's side main glass, I'm getting darned good at it. And I hope to never have to do it again. But I do still have almost 100 feet of glass setting tape left.
