#### NCC Meeting Minutes May 9, 2023 By Sandy Houck

Chairman Bob Grauer welcomed 26 members to the May meeting at 7:00 pm via Zoom. He asked us to introduce ourselves.

Bob began the meeting by reporting all the good feedback about the Los Gatos Spring Meet and asked if any other members had comments. Many liked the venue, the variety of cars on display, and the good participation. One comment was that the show of people was basically the same as it has been in Suisun City. The only negative was that completing the judging was rushed at the end of the day. Thank you to Wayne Yurtin for all his planning and organizing a successful meet.

The next meeting will be an in-person Social Canned Food Drive at St. Peter's Episcopal Church in Oakland on June 14<sup>th</sup>. It is a Wednesday due to the room availability. Offering Zoom was discussed, but it will defeat the purpose of having an in-person social meeting.

<u>Secretary Report</u>: Sandy Houck The April minutes were approved as submitted by the Board.

<u>Membership</u>: Sharyl Ingham We now have 117 paid members.

#### Treasurer's Report: Chris Moore

Bob described changes in the new Treasurer transition. The Chapter is viable and in good financial shape. Chris has transitioned to QuickBooks and is doing profit and loss (P&L) reports. He showed slides that were P&L reports for various Chapter operations and events. The Spring Meet had a loss but it was about the same as that in 2022.

#### Judging: Mike Ingham

The Los Gatos car judging results and judging points were entered into the NCRS judging database by Mike, reviewed and approved by Dave Brigham, and the judging sheets and certificates were sent out by Sharyl within the week.

Rick Gower asked about the manuals, so Mike mentioned that the '53-'55 manual is being updated, and the errors in the `63-`64 manual are being fixed by the new team leader, but it is not yet clear when these two manuals will be available. The new manual for C6's is in print and will be offered at the Convention.

Beth Bartow asked if requesting photos of trim and VIN tags could be an option to be sent in with meet registrations, suggesting that it would save time. It was explained that trim and VIN tags are only to be reviewed by the Team Leader ON the day of judging. Taking any photos of anyone's trim or VIN tag is prohibited without the owner's permission.

#### New Business:

<u>Chapter Top Flight Award (CTFA)</u>: Jeff Blakeslee

Jeff shared the Quarterly report showing that we are up-to-date on the required and variable activities. Bob mentioned that the checks to Meals on Wheels in the six counties will be delivered either in person or by mail. Mike clarified that the matching funds are 50% and have never been 100% matched.

#### <u>NCRS Region IX Director and Vice-President</u>: Mike Ingham

The NCRS Website Administrator John Waggoner is planning to retire and posted a "help wanted" ad in the monthly NCRS email blast. Mike happily announced that NCC member Mick Dreeling was interviewed by the IT Team and some Board members and will be working with John to learn the various responsibilities. Congrats Mick.

<u>NCC Fall Meet, Sonora</u>: Jerry Fuccillo We have a contract for 30 rooms at the renovated Heritage Inn for September 22 to 23. Jerry encourages us to enjoy the many wineries and other activities in the Sonora area.

<u>Convention in French Lick</u>: Mike Ingham Registration numbers are good; seems to be back to pre-pandemic levels. Over 100 cars will be judged.

Mike mentioned that all the Region Directors were to reach out to their Chapters asking individuals or their Chapters to donate towards the sponsorship for the Judges and Tabulators meals @\$300. <u>Technical Discussion Board</u>: Gary Beaupre and Rick Gower

Gary reported that a Mick Dreeling post on his '71 exhaust system got many replies.

Also, there were a lot of views on a posting of the discussion board's Terms of Use; that is, what is allowed and what's not. Mike clarified that the Terms of Use have not changed, they were just posted as a reminder to users.

Rick reported that John Amgwert, NCRS founding member #3, has been elected to the National Corvette Museum Hall of Fame.


