Chairman's Message – Pass It Along By Jeff Blakeslee

Now that I'm back at restoring a car, or at least heading in that direction, I'm noticing the difference in available services between now and when I restored my last car 7 years ago. I must first admit that I do almost everything myself, which turns out to be a good idea about 70% of the time. So, while I'm not looking to outsource all that much, there are times when it is better to have an expert do it.

When I decide to have an item restored by others, sometimes it's because I realize that it will cost more for the tooling than to have the task performed by others. Other times it is the learning curve and a low probability that I will get it right the first time... and I'm not in the mood for that much practice. Or possibly it's the availability of parts, or rather the lack thereof, and you just can't buy what you need to restore a given item. No matter what the

reason, the NCRS has always been the place to go when you want something done right.

I have a couple items on my list right now. The first is the original fuel pump, and it's the crimped body type that can't be properly rebuilt without specialized tooling and a one-off parts manufacturing run. There is at least one person in the NCRS community who has this capability, but it appears that there will be a long wait at best and may possibly end up being completely unavailable before mine reaches the front of the line. The second item on my list is the AC compressor for my 69, and again, there is an NCRS specialist, but the availability of the service is uncertain. In the case of the latter, it appears there may be options outside of NCRS, but the results are less certain.

To be blunt, the problem is that we are all getting older, and the folks who have historically been the go-to for these services no longer have the same interest or capability to carry on at a level required to serve the need. Furthermore, this shortage of services is more likely to get worse than better, but that does not have to be the case.

I believe that there are Corvette enthusiasts who are a bit younger, maybe at an early retirement age, that would like to become a specialist in a specific Corvette restoration service. Maybe partly for personal satisfaction, but also to provide a supplemental retirement income. Corvette restorers are generally talented folks who can learn these skills quickly. Maybe it's just my wishful thinking, but I think NCRS could encourage the pairing of a would-be apprentice with a service provider who may be ready to call it guits. This could also provide a pathway for existing expert providers to sell their inventory and equipment. I realize we already have forums and publications where this could be advertised, but that is different than a formalized program. If the club is going to continue to thrive in the future, steps need to be taken now to ensure that we are the place to go when you decide to restore your Corvette. And that means providing a pathway for the juniors to learn from, and yes, eventually replace the seniors. To sum this up, we should all "pass it along", and NCRS can and should encourage that process.

NCC Board Meeting Minutes – August 12, 2025

Treasurer's Report:

Chris Moore was absent. He sent a report to Jeff. Chris has received registration payments for the October Meet.

Membership Report:

Sharyl reported we are stable with 105 members. She will encourage others to join at the Las Vegas convention.

Vettectera Editor:

Mike noted that there is a good response to ads posted in the Vettecetera. He quickly sold his trailer.

NCRS President/Region IX Director:

Mike briefly commented on the National Convention. He will discuss it in more detail during the General Meeting.

Old Business:

Mike reported there will be two or three '57 cars at the October one-day meet.

Jeff commented further on our decision to withdraw from the CTFA program. There will be a new person in charge of the program at National beginning in 2026 so he is hoping there will be changes in the program requirements and reporting.

New Business:

Dave Houlihan has offered to show a Dollars and Cents presentation about the value of correct parts versus judging points. Sharyl is exploring whether the Spring Meet can be held at the Holiday Inn Express in Suisun City.

Now is the time to start planning for a Regional Meet in 2027. The Southern California Chapter is taking the lead and is inviting NCC and the Central California Chapter to participate. We need to further discuss the commitments.

The Board Meeting adjourned at 6:59 pm.

NCC Meeting Minutes – August 12, 2025

Chairman Jeff Blakeslee called the Meeting to order at 7:01 pm and welcomed 25 members. He asked for introductions stating where we live and the Corvette(s) we own and asked: "What car in your life were you most bonded with?" For some it was an early Corvette, and for others it was various cars from the '50s and '60s, including a '72 Firebird, an Oldsmobile 442, an Austin Healy 3000, a '57 Chevy, a '57 Bel Air, and a NSX.

Las Vegas National Convention:

Mike Ingham reported that so far there are 371 registrations for over 660 people, and 105 cars to be exhibited plus Sportsmen. Sharyl Ingham is working hard on the registrations. John Tidwell is working hard on purchasing and accounting. Attendance is not as high as it is for conventions on the East Coast and the Midwest, but this is good for the West Coast. Sharyl told us to dress Western for the Hoedown at the Convention's welcoming reception.

Fall Meet, October 4 in San Leandro: Mike is expecting three '57 cars. Bob Grauer may give a tech session on Corvette documentation. For those who want to stay overnight, Bob suggests the Marina Inn.

Jeff's Garage:

In lieu of a presentation, Jeff asked us to diagnose what was wrong with his '69 engine. The car would run great and then it wouldn't idle. It felt like retarded timing. After a few hints, we determined it was the vacuum advance canister.

Technical Discussions:

Gary Beaupre did not have any items of significant interest from the Tech Board. Bob Grauer is looking for a replacement correct AC fuel pump for his '69. The current one is leaking.

Ken Albers found that his '36 Chevy temp gauge operates with a gas filled capillary tube. Mason McNay is planning to use Evans waterless coolant in his '64 after replacing the radiator and hoses.

Bob Gauer will be giving a presentation for the Southern California Chapter at the Browning car collection where there is a nice C1 collection.

NCC Road Tour:

Ken Albers is planning a tour that will start at Solano College, take the back roads around Berryessa, stop for a visit to the Albers garage and then end in Rio Vista. Mark your calendars for October 18.

Open Discussion:

The Novato Nostalgia Days will be October 11. We are not planning to go as a group this year, but Jeff encourages us to attend individually. You may be able to park with the North Bay Corvette Association.

Adjournment:

The meeting adjourned at 8:08 pm.

There will not be a meeting in September because we will all be in Las Vegas. So, the next Zoom meeting will be Tuesday, October 14 at 6:30 pm for the Board Meeting and 7:00 pm for the General Meeting

Procrastination is never a good thing. Many of the members started to register but did not complete the process so it was saved as a preregistration. To complete your registration, you need to pay. If you don't pay, you aren't actually registered. I plan to bring the list of those that didn't complete their registrations just in case they show up.

Almost a week after registration closed on July 21st a member called and mentioned that he hadn't received any information about where he can park his trailer. I asked his name. 


